These terms will be considered binding and no variation or modification of this contract shall be considered without the written consent of both Neil Hutchison and the client.

**Payment:**

This contract comes into force on receipt of a minimum booking fee of £200 together with this form completed with all relevant information from the client.

Dates are only reserved on receipt of the booking fee in cash, cleared cheque or electronic transfer (details available on request).

**Balance Payment:**

The balance of the agreed package is to be made in cleared funds not later than 60 days prior to the wedding day. Failure to pay the balance will be deemed a notice of cancellation. Additional Albums, Prints and or frames may be purchased after the wedding and paid for at time of order.

**Creative Licence:**

Full creative licence will be given to Neil Hutchison with regard to the choice of style, locations and poses used during the wedding day. When a disk of images is included in the package Neil retains the right to select the photographs for inclusion according to his personal standards and judgment which will be deemed to be correct. As many unforeseen factors may affect the coverage possible including but not limited to adverse weather, availability and willingness of subjects Neil will endeavour to honour all requests for specific poses, styles, backgrounds and groups but cannot guarantee all requests can be met.

**Force Majeure:**

In the unlikely event of total photographic failure, injury or sickness beyond Neil's control liability shall be limited to a full refund of monies paid. Your statutory rights are not affected..

**Copyright:**

The entire copyright in the Photographs is retained by the Photographer at all times throughout the world and may be used for promotional purposes. The only exclusion to this term is in the case of a disk of images being included as part of the package. In this instance the license only applies to the client and its benefit shall not be assigned to any third party without the Photographer's written permission

**Cancellation:**

Should the client cancel a scale of charges will apply to compensate Neil for loss of income.

More than 4 calendar months prior to the wedding date - booking fee

3-4 calendar months prior to wedding 50%

2-3 calendar months prior 75%

Less than 2 calendar months prior 100%

In the event of a postponement all money paid will be applied to the new wedding subject to Neil's availability. If unavailable the postponement will be deemed a cancellation. If Neil books another wedding on the date in question then a refund shall be made minus expenses incurred. You may cancel in writing to the address at the top of this form or to the email address above.

**Privacy Policy**

Neil will only store your contact and wedding details for use in supplying his service to you. These details will be kept safe and not passed on to any third parties either companies or individuals. You may request removal of your details in writing any time after the wedding.
